INDEPENDENT AUDITORS' REVIEW REPORT

The Board of Directors of Ushakiran Finance Limited

We have reviewed the accompanying statement of unaudited financial results of M/s. Ushakiran Finance Limited ('The Company') for the quarter and Nine Months ended 31st December, 2018 ("the statement") attached herewith, being submitted by the company pursuant to Regulation 33 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. CIR/CFD/FAC/62/2016 dated 5th July, 2016.This statement is the responsibility of the Company's management and has been approved by the board of directors. Our responsibility is to issue a report on these interim financial statements based on our review.
